<b><u>9:00</u></b>	16PR00248	Estate of Sawyer, Shirley Ann	As previously indicated, Ms. Eaton was already appointed as Administrator of the Estate of Shirley Ann Sawyer and Letters were issued on September 13, 2016. Then, on May 28, 2024, the Court settled and approved Ms. Eaton's final distribution petition. The Court notes that its Order of May 28, 2024 on the First and Final Account and Report authorized Kim Eaton, as Administrator, to transfer the Estate's interest in the real property to Kim Eaton as the sole beneficiary of the Estate. Thus, all that remains is the distribution of assets pursuant to the Court's May 28, 2024 Order, and the filing of the Ex Parte Petition for Final Discharge and Order [Mandatory Judicial Council Form DE-295]. Should Ms. Eaton wish to sell the real property in her individual capacity, she is not precluded from doing so after distribution from the Estate, nor are amended Letters required. The Petition is denied, and this matter is continued to September 16, 2025 at 9:00 a.m. for a Review Hearing for status of filing the required final discharge petition.
