Here, Respondent has failed to allege any new or different facts, circumstances, or law and the motion is denied. In regard to the motion for judgment on the pleadings, the Court finds that such a motion "may not be brought on grounds previously raised by demurrer unless there has been a material change in the law since the demurrer was overruled." <i>Tung v. Chicago Title Co.</i> (2021) 63 Cal. App. 5th 734, 757 citing <i>Code of Civil Procedure</i> §438(g)(1). Here, Respondent has already advanced the same statute of limitations argument by demurrer in this matter, which the Court overruled. There being no material change in the law since that prior ruling, the motion is denied.
