TENTATIVE RULINGS**

**1. 22CV02898 Dasbach, Catherine et al v. Moore, James MD et al**

*EVENT: Defendant Enloe Medical Center's Motion for Judgment on the Pleadings as to Plaintiffs' Entire Complaint (Continued from 1/8/25)*

At the last CMC hearing, defense counsel reported to the Court he understood it was Plaintiff's counsel intention to dismiss this Complaint. All counsel are to appear and advise the Court of the status of this matter.

**2. 23CV00846 Matlock, Kayla v. Volkswagen Group of America, Inc.**

*EVENT: Motion to Compel Deposition of Plaintiff Kayla Matlock*

Motion to Compel Deposition of Plaintiff Kayla Matlock is now partially moot in light of the February 13 deposition. The issue of sanctions is not moot. Plaintiff (not Plaintiff's counsel) is sanctioned in the amount of \$1,910.00. Defendant should not have been required to file this motion. Plaintiff's failure to provide an available date for a period exceeding 6 months is unacceptable.

Defendant shall prepare and submit the form of order within 2 weeks.

*EVENT: Minor's Compromise Petition*

*EVENT: Motion for Order that Matters in Request for Admission of Truth of Facts Be Admitted*

Motion for Order that Matters in Request for Admission of Truth of Facts Be Admitted is GRANTED. The Court will sign the proposed order.

6. **24CV03814 Hamrick, Cecil Irene v. Adkins, Lil Mae**

*EVENT: Motion to be relieved as counsel (Plaintiff)*

*EVENT: Change of name (adult)*

**9. 24CV04073 In re: Hunt-Parsons, Emily Annemarie**

**10. 18CV03287 In re: Beyhawck, Alek Luciano**

*EVENT: Motion to Expunge and seal case*
