#### 1-2. 23CV00369 Yates, Chad v. Ellenberger, Jared

EVENT: (1) OSC re Preliminary injunction preventing Defendant from disposing of receivership assets and his personal residence.

(2) Plaintiff's Ex Parte Application for Issuance of Temporary Restraining Order and Preliminary Injunction

Plaintiff's request for a preliminary injunction enjoining Defendant and his agents from selling the residential property located at 25155 Post Ave., Orland, CA 95963, or from conducting a similar action which dispossesses Defendant of the aforementioned property is granted. Additionally, Defendant is enjoined from disposing of any property identified in the Receiver's inventory. This injunction will be effective until the first day of the Court Trial – July 28, 2025.

Plaintiff is required to post an undertaking in the amount of \$7,000. The injunction will be operative upon the posting of the undertaking.

Plaintiff shall prepare and submit the form of order.

#### 3-4. 23CV02706 Adams, Earl et al v. Fitzgerald, Mike

EVENT: (1) Plaintiff's Motion to Compel Further Answers to Form Interrogatories, Set One

(2) Plaintiff's Motion to Compel Further Answers to Request for Production of Documents, Set One

#### Form Interrogatories

Nos. 1.0, 2.1, 2.3, 2.6, 2.7, 3.7, 4.2, 11.1, 12.7, 14.1, 50.1

The motion is denied. Substantive responses were provided, and while some of the responses may have been technically incomplete, the Court fails to see the practical benefit in requiring further responses to these requests.

Weil & Brown, California Practice Guide: (the Rutter Group 2024) Civil Procedure Before Trial

[8:1180] Ruling on motion to compel further answers: The granting or denial of a motion to compel rests within the court's sound discretion.

[8:1181] Factors considered: The ruling usually is based on consideration of the following factors:

- The relationship of the information sought to the issues framed in the pleadings;
- The likelihood that disclosure will be of practical benefit to the party seeking discovery;
- The burden or expense likely to be encountered by the responding party in furnishing the information sought. [Columbia Broadcasting System, Inc. v. Sup.Ct. (Rolfe) 1968 263 CA2d 12,19 69 CR 348, 352]

Nos. 2.5, 2.8, 4.1, 12.1, 12.2, 12.3, 12.5, 15.1, 50.2

The motion is granted. The responses are incomplete and the requests are reasonably calculated to discover information pertaining to material issues in the case. Further responses are required which respond to the interrogatory and each subpart completely. Defendant cannot simply refuse to answer an interrogatory on the basis that it may be a public record. The code requires a complete response based on the information reasonably available to him. This requires at least a good faith effort to obtain the information.

As to 50.2, the response was non-responsive. The request seeks to identify any breaches of the agreement. The response does not address whether there were any breaches of the agreement.

#### **Production of Documents**

No. 1

The Court's ruling is contingent on Defendant's further response to Form Interrogatory no. 12.3. As noted, the motion is granted as to 12.3. It appears to the Court that Defendant may be confused as to the term "written or recorded statement." The survey itself is not a written or recorded statement. If the further responses indicate that there is, in fact, a separate written recorded statement other than the survey itself, then this motion is granted and the document(s) must be produced. If the further response clarifies that there are no other documents separate from the survey, then this motion is denied.

To the extent this motion is granted, Defendant shall provide further responses within 10 days of notice of this order. If additional documents exist, Defendant shall produce those documents concurrently with his further responses.

Plaintiff's request for sanctions is denied.

Plaintiff shall prepare and submit the form of order within 2 weeks.
