

**1. 23CV02903 Salvagno, Rachelle v. Tri Counties Bank**

*EVENT: Motion for Order Deeming Defendant's Requests for Admissions, Set One, as Admitted and Request for Monetary Sanctions*

Motion for Order Deeming Defendant's Requests for Admissions, Set One, is moot. Request for sanctions is denied. In this Court's view, sanctions are inappropriate when the moving party represents a further meet and confer letter is forthcoming, the responding party relies on that representation, and the moving party changes course and files a motion without further communication. Although technically a further meet and confer letter was not required under these circumstances, once Defendant represented a further meet and confer letter was forthcoming, counsel should have followed through with that representation before filing this motion.

**2-3. 23CV03127 Wilson, Daedalys et al v. Park, Lisa et al.**

*EVENT: (1) Plaintiffs' Motion to Continue Trial Date, Trial Readiness Conference; and all Trial Related Deadlines*

*(2) Motion for Leave to File a Second Amended Complaint*

Plaintiffs' Motion to Continue Trial Date, Trial Readiness Conference; and all Trial Related Deadlines is moot in light of the ex parte ruling vacating the trial and related dates.

Motion for Leave to File a Second Amended Complaint is granted. The Second Amended Complaint attached as Exhibit 1 to the Declaration of Angela Hooper ISO Motion For Leave to File Second Amended Complaint is deemed filed.
